The applications should be addressed to the Mission director, Horticulture & cash crop Development department, Government of Sikkim and should clearly mention the component he/she is applying for. All the applications should reach the Office of the Joint Director (Horticulture), of concerned district by 30th November 2018. This is a back ended subsidy program (50%) under Horticulture & Cash Crop Development Department, Government of Sikkim, and is open to locals of sikkimese origin only.

NOTICE INVITING APPLICATIONS FOR SUBSIDY UNDER MIDH 2018-19.

Applications are invited from interested individuals/ SHG's, FPO's and other agro-based industries/firms etc. For availing assistance under various components of Integrated Post Harvest Management and Establishment of Marketing Infrastructure under HMNEH (MIDH) 2018-19.

The applications should be addressed to the Mission Director, Horticulture & cash crop Development department, Government of Sikkim and should clearly mention the component applied for. All the applications should reach the Office of the Joint Director (Horticulture), of concerned district by 30th November 2018. This is a back ended subsidy program (50%) under Horticulture & Cash Crop Development Department, Government of Sikkim, and is open to locals of sikkimese origin only.

The brief details of the various components are as under:

{A} INTEGRATED POST HARVEST MANAGEMENT

1. Functional pack house/on farm collection unit

- a) **Description:** A collection Unit is a structure made up of brick wall with M.S. Grill work claddings and GCI sheet roofing on an approximate area of 240 Square feet. The basic purpose of having this structure is facilitate the farmers of the area to collect all their organic farm products in a designated area for primary grading, sorting and packaging for further transportation and marketing. The assistance is 50% of the capital cost.
- b) Total cost per unit: Rs.4.00 lakh
- c) Rate of Assistance:- Rs.2.00 lakh per unit.
- d) Eligibility of applicant: Individuals/ SHG's, FPO's.
- e) **Mode of Execution:-** (i) The selection of beneficiaries shall be done by the district horticulture office as per the allotted target from among the applications based on suitability of locations, Utility of the FPO's etc.
 - (ii) The assistance of Rs.2.00 lakh shall be in the form of supply/ installation of these units which shall be carried out through SIMFED.
 - (iii) **BeneficiariesContribution:** The beneficiaries contribution of 50% i.e. Rs.2.00 lakh will have to be in the form of cost of land, site leveling , drainage & electricity.

2. Integrated pack house

- a) **Description:-** It is composite structure which should have a washing area, a grading and sorting and processing area. A cold store with minimum temperature range of upto 2 degree Celsius with internal electrification and matching power backup. It should include all the Civil works like plant shed, protective works, water supply works etc. The location should be selected where most of the clusters are growing high value and perishable crops. The total cost per unit is Rs.50.00 lakh with 50% credit linked subsidy.
- b) Total cost per unit (9m x 18m) : Rs.50.00 lakh.
- c) Rate of Assistance:- Rs.25.00 lakh per unit.

d) **Eligibility of Applicants** : Progressive farmer, FPO's, SHG's, Agro based industries owned by local. They will have to submit detailed project proposal.

(e) **Mode of Execution:-** (i) The selection of beneficiaries shall be done by a committee after proper scrutiny & evaluation of the detailed Project proposal

(ii) The 50% assistance shall be released in phases based on the progress of work and upon the committee's recommendation.

3. Pre-Cooling Unit

a) Description:- It is a modular, pre-fabricated, PUF insulated panels for fast cooling of horticultural crops like fruits, vegetables & flowers with a capacity of 6 MT. The temperature range of which should be upto 2 degree Celsius

b) Total cost per unit : rs.25.00 lakh

c) Rate of Assistance (50%) :- Rs. 12.50 lakh per unit.

(d) Eligibility of Applicants : Progressive farmer, FPO's, SHG's, Agro based industries

(e) **Mode of Execution:-** (i) Selection of the beneficiaries shall be done by the Committee from among the applicants based on suitability and viability of locations.

(ii) The 50% assistance will be in the form of supply & installation of prefabricated units which shall be carried out through SIMFED.

(iii) The beneficiaries contribution of 50% i.e. Rs.12.50 lakh will have to be in the form of cost of land, site leveling , construction of suitable sized enclosure, drainage & electricity.

4. COLD ROOM STAGING

(a) **Description:-** It is a modular, pre fabricated, PUF insulated panels for cooling/ safe storage of horticultural crops like fruits, vegetables & flowers. The temperature range of which should be 2 to 8 degree Celsius. It is basically a modular walk in type cold room. The total cost per unit of 30MT capacity is rs.15.00 lakh.

(b) Rate of Assistance (50%) :- Rs. 7.50 lakh per unit.

(c) Eligibility of Applicants : Progressive farmer, FPO's, SHG's, Agro based industries

(d) **Mode of Execution:-** (i) Selection of the beneficiaries shall be done by the Committee from among the applicants based on suitability and viability of locations.

(ii) The 50% assistance of Rs.7.50 lakh will be in the form of supply/ installation of the pre-fabricated cold storage units which shall be carried out through SIMFED.

(iii) The beneficiaries contribution of 50% i.e. Rs.7.50 lakh will have to be in the form of cost of land, site leveling , construction of suitable sized enclosure, drainage & electricity.

5. Ripening Chamber :

(a) Description:- Ripening is the process by which fruits attain their desirable flavour, quality, colour and other textural properties. For the purpose of these guidelines, 11 cubic metres of storage space is considered equivalent to 1 Metric Ton ripening capacity. Ripening chambers can be designed for multi-tiered pallet based storing or structures for basic storage.

(b) The total cost per unit is Rs.50.00 lakh per unit of 50 MT capacity.

- (c) Rate of Assistance (50%):- Rs.25.00 lakh per unit.
- (d) Eligibility of Applicants : Progressive farmer, FPO's, SHG's, Agro based industries.
- (e) **Mode of Execution:-** (i) Selection of the beneficiaries shall be done by the Committee from among the applicants based on suitability and viability of locations.
 - (iv) The 50% assistance of Rs.25.00 lakh will be in the form of supply/ installation of the prefabricated cold storage units which shall be carried out through SIMFED.
 - (v) The beneficiaries contribution of 50% i.e. Rs.25.00 lakh will have to be in the form of cost of land, site leveling , construction of suitable sized enclosure, drainage & electricity.

6. Primary/Mobile/Minimal Processing Unit

- a) Description:- This Unit is a structure made up of brick wall with M.S. Grill work claddings and GCI sheet roofing. It will have basic minimum processing facilities and equipment's for cleaning, grading, sorting, and primary processing like cutting, grinding and drying. The unit will be crop and cluster specific.
- b) Total cost per unit : rs.25.00 lakh per unit of
- c) Rate of Assistance (55%) :- Rs.13.75 lakh per unit.
- d) Eligibility of Applicants : Progressive farmer, FPO's, SHG's, Agro based industries They will have to submit detailed project proposals.
- e) **Mode of Execution:-** (i) Selection of the beneficiaries shall be done by the Committee from among the applicants based on suitability and viability of project proposals.
 - (ii) The 55% assistance of rs.13.75 lakh shall be released in phases based on the progress of work and upon the committee's recommendation..

{B} ESTABLISHMENT OF MARKETING ESTABLISHMENT FOR HORTICULTURAL PRODUCE.

1. Rural Market/ ApnaMandi

- a) Description:- This will be an RCC/ MS framed structure with GCI sheet roofing with facilities for retailing and whole selling of farm products along with a provision of temporary storage.
- b) Total Cost per unit: Rs.25.00 lakh
- c) Rate of Assistance(55%):- Rs.13.75 lakh per unit.
- d) Eligibility of Applicants : PSUs, FPO's, SHG's, Agro based industries
- e) **Mode of Execution:-** (i) Selection of the beneficiaries shall be done by the Committee from among the applicants based on suitability and viability of locations.
 - (ii) The 55% assistance of rs.13.75 lakh shall be in the form of the construction of the Apnamandi shed.
- (iv) The beneficiaries contribution of 45% i.e. Rs.25.00 lakh will be in the form of cost of land, drainage & electricity.

2. Retail markets/outlets (environmentally controlled).

- a) Description:- This will be an RCC / MS structure with GCI sheet roofing with facilities for retailing of farm products along with a provision of temperature control.
- b) Total Cost per unit : Rs.15.00 lakh
- c) Rate of Assistance (50%):- Rs.7.50 lakh per unit.
- d) Eligibility of Applicants Progressive farmer, FPO's, SHG's, Agro based industries. They will have to submit detailed project proposal.
- (e) **Mode of Execution:-** (i) The selection of beneficiaries shall be done by a committee after proper scrutiny & evaluation of the detailed Project proposal.
- (f) The 50% assistance of rs.7.50 lakh shall be released in phases based on the progress of work and upon the committee's recommendation..
